



NOTICE TO BIDDERS

NOTICE IS HEREBY GIVEN that the City of Weston, Florida will be accepting sealed bids for:

**INDIAN TRACE ACCELERATION LANE /
BONAVENTURE BLVD. & ROYAL PALM BLVD. TURN LANE EXTENSION
CITY BID No. 2012-01
CGA PROJECT No. 10-3740 / 96-2465**

The work shall generally consist of: Extension of the existing southbound left-turn lane on Bonaventure Boulevard at the intersection with Royal Palm Boulevard as well as the construction of an acceleration lane on Indian Trace from the Eagle Pointe Elementary entrance to Lake Boulevard. This project includes related paving, grading, drainage, signing & marking, landscaping, irrigation and lighting work as shown on the project plans, located at Indian Trace and in Bonaventure Blvd. @ Royal Palm Blvd in the City of Weston.

Sealed bids will be received by the City Clerk until **11:00 a.m., local time, on Tuesday, March 6, 2012** at the City of Weston, City Hall located at 17200 Royal Palm Boulevard, Weston, Florida. The official clock at the City Hall reception desk shall govern. Bids received after this time will be returned unopened.

PROJECT DOCUMENTS

Project Manuals may be examined at the offices of Calvin, Giordano & Associates, Inc., or the City of Weston, at the referenced address.

Bids shall be submitted on the form(s) provided. Volume 1 of the Project Manual must be submitted as part of the proposal.

MANDATORY PRE-BID CONFERENCE

A mandatory Pre-Bid Conference is scheduled for **11:00 a.m., Monday February 13, 2012**, at the Weston Community Center, 20200 Saddle Club Road, Room B, Weston, Florida 33327. All contractors planning to submit a bid are required to attend this meeting. Contractors should allow sufficient time to insure arrival prior to the indicated time. Bids from those who have failed to attend will not be opened. Failure of a bidder to be present for the entire mandatory pre-bid conference, beginning at the time stated above and concluding at the dismissal of the mandatory pre-bid conference by the City shall render a bidder to be deemed non-responsive and the bid shall not be considered for award.

Contractors arriving past the indicated time will not be eligible to submit a bid. Decisions of the City shall be final. The official clock at the location of the Pre-Bid Conference shall govern.

BID DOCUMENTS

Envelope containing bid must be sealed and be clearly marked, " **Indian Trace Acceleration Lane / Bonaventure Blvd. & Royal Palm Blvd. Turn Lane Extension, City Bid No. 2012-01, CGA Project No. 10-3740 / 96-2465**". The bid shall contain 2 complete copies and one (1) unbound original, and is required to be submitted to the City by the date and time indicated above. Each copy shall contain all required information in order to be considered responsive.

Once a bid has been submitted to the City at or prior to Tuesday, March 6, 2012, 11:00 a.m., local time, it shall not be returned to the bidder for any reason. The withdrawal, modification or correction of a bid after it has been opened by the City shall constitute a breach by the bidder.

All bid prices shall be guaranteed firm for a minimum of 90 calendar days after the submission of the bid. No bidder may withdraw its bid within 90 calendar days after the bid opening date.

Bid security in the form of a Bid Bond acceptable to the City or Cashier's Check made payable to the "City of Weston" in an amount equal to five percent (5%) of the bid, will be required. Guaranty Bonds in the form of Performance Bond and Payment Bond, in an amount equal to 100% of the contract will be required. The Surety Company shall have at least the minimum ratings of "A-Excellent: FSC VII", as described in the Instructions to Bidders.

Bids will be publicly opened at the City of Weston, City Hall, located at 17200 Royal Palm Boulevard, Weston, Florida at 11:00 a.m., on Tuesday March 6, 2012. The official clock at the City Hall reception desk shall govern. Award of bid will be made at a City Commission meeting.

Bidders/proposers shall demonstrate successful performance of projects of a similar magnitude, scope, value and trade as this project.

The City Commission of the City of Weston reserves the right to reject any and all bids, to waive any informality in a bid and to make awards in the best interests of the City.
