### ROAD CLOSURES FOR THE 2010 RUN FOR TOMORROW (ROTARY HOLIDAY RUN)

**Sunday, December 12<sup>th</sup> 6:00 A.M. – 10:30 A.M.**

**WHAT:** The Run For Tomorrow features a 5K run, half marathon and 1.5 mile fun walk. Motorists in Weston should allow for additional time in order to reach their destination.

**WHEN:** Sunday, December 12, 2010 from 6:00 a.m. to 10:00 a.m.

**WHERE:** Races begin and end at Weston Town Center.

**CLOSURES:** 6:00 A.M. – 10:00 A.M. Bonaventure Blvd., both directions, between Royal Palm Blvd. and South Post Road

**DELAYS:**  
6:30 A.M.- 10:30 A.M.

- Royal Palm Blvd., both directions, between Bonaventure Blvd. & Saddle Club Road
- Glades Parkway, both directions, between Saddle Club Rd. & Glades Circle South
- Bonaventure Blvd., both directions, between Three Village Rd. & Royal Palm Blvd.
- Bonaventure Blvd., both directions, between South Post Road & Griffin Road

6:00 A.M.-8:00 A.M.

- Town Center Circle
- Town Center Blvd., northbound, between Town Center Circle and Three Village Road
- Town Center Blvd., southbound, between Town Center Circle and Royal Palm Boulevard
- Three Village Road, eastbound, between Town Center Blvd and Bonaventure Boulevard

Orange safety cones and signs will designate the lanes to be used for runners and vehicles.
