**City Manager Update of Hurricane
Irma Restoration Activities**

A. Debris removal within gated communities.

B. Gated Communities.

Mr. Flint stated the City is not eligible for reimbursement for clean-up within the gated communities without prior approval from FEMA. Some of the gated communities have cleaned up on their own. Discussion and questions ensued between the City Commission, City Manager and City Staff. The City will be filing a thorough request for approval to FEMA on September 20th.

Resident Joan Axthelm commented on communication to the HOAs during the event. Resident Mary MacFie commented on the FEMA rule changes for gated HOA debris removal.
